PMPM Scheduling Rules

The method for determining how the schedules are developed for the PMPMs is explained below.

HLA: As requested by LDH, the payment should be made on the closet Tuesday to the 15th of the month.

CSOC: As requested by LDJ, the payment should be made at the same time as the HLA monthly payment.

Dental: As requested by LDH, the payment should be made the 3rd week of each month.
