SUBJECT:

Notification of Labeler Terminations, effective 10/01/2018

Effective October 1, 2018, the Louisiana Department of Health (LDH) will no longer pay for drug products from manufacturers (labelers) who provided confirmation that they will not be renewing their Medicaid National Drug Rebate Agreement (NDRA); or manufacturers (labelers) who failed to complete, sign and submit the updated rebate agreement by September 30, 2018.

Medicaid will no longer pay for any drug product with a national drug code (NDC) beginning with their 5-digit labeler code beginning October 1, 2018.

Following is a list of 5-digit labeler codes for manufacturers that, so far, have confirmed they will not be renewing or have <u>not</u> completed, signed and submitted updated rebate agreement.
