**SUBJECT:** Louisiana Medicaid Pharmacy Diabetic Supplies Preferred

Drug List (PDL)/Non-Preferred Drug List (NPDL) Updates

The Louisiana Medicaid Fee for Service (FFS) Pharmacy Program will update the Diabetic Supplies Preferred Drug List (PDL)/Non-Preferred Drug List (NPDL). The update applies to pharmacy claims submitted to Gainwell Technologies for FFS and to Prime Therapeutics, LLC for MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare).

### 1.) Ascensia Contour Diabetic Supplies

Effective May 2, 2025, the Ascensia Contour Diabetic supplies will move from non-preferred to preferred on the PDL. Pharmacy claims for Ascensia Contour Diabetic Supplies will process as a preferred product and do not require a prior authorization.

## 2.) Lifescan One Touch Diabetic Supplies

Effective June 1, 2025, the Lifescan One Touch Diabetic Supplies will no longer be covered by the Louisiana Medicaid Pharmacy Program. Pharmacy claims for Lifescan One Touch Diabetic supplies will deny at Point of Sale for product "Not Covered by Medicaid."
