SUBJECT: Louisiana Medicaid Pharmacy COVID-19 Vaccines

Administration Rate Update

Effective November 1, 2024, the Louisiana Medicaid Fee for Service (FFS) Pharmacy Program and Managed Care Organizations (MCOs) will update the administration rate for COVID-19 vaccines. The COVID-19 vaccine maximum administration rate will increase from \$29.58 to \$30.78. This applies to **pharmacy claims** submitted to FFS Medicaid and Louisiana Medicaid MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare).

COVID-19 Vaccine Updates

- Louisiana Medicaid will reimburse enrolled pharmacies for the <u>administration fee and ingredient cost</u> (at WAC for local pharmacies) for COVID-19 vaccines administered to recipients nineteen years of age and older.
- Louisiana Medicaid will reimburse enrolled pharmacies for the <u>administration fee only</u> for COVID-19 vaccines administered to recipients <u>under</u> nineteen years of age because the vaccines are available through the Louisiana Vaccines for Children (VFC) program.
- Louisiana Medicaid shall reimburse for vaccine counseling as a pharmacy benefit in the amount up to \$19.72 or billed amount, whichever is lower when the criteria is met in recipients less than 21 years old.
- The COVID-19 vaccine maximum administration rate will increase from \$29.58 to \$30.78. **COVID-19 vaccine administration reimbursement is a stand-alone administration fee of \$30.78.** There will be no reimbursement for the dispensing fee and no "at home" administration fee for COVID vaccines will be reimbursed.
