SUBJECT: Louisiana Medicaid Pharmacy Single Preferred Drug List (PDL) Update

for Epoetin Alfa (Epogen®) - Effective April 1, 2022

Effective April 1, 2022, the Louisiana Medicaid Fee for Service (FFS) Pharmacy Program will update the Preferred Drug List (PDL) status of epoetin alfa (Epogen®) from non-preferred to preferred. The update of epoetin alfa (Epogen®) to preferred PDL status applies to pharmacy claims submitted to FFS and Managed Care Organizations (Aetna, AmeriHealth Caritas, Healthy Blue, Louisiana Healthcare Connections, and UnitedHealthcare).

Epoetin Alfa (Epogen®)

Due to a supply disruption of the preferred agent epoetin alfa-epbx (Retacrit®), the prior authorization (PA) status of epoetin alfa (Epogen®), is changing from non-preferred to preferred. Louisiana Medicaid FFS Pharmacy Program has determined that this change to preferred status will allow ease of access for patients and dispensing pharmacies. Pharmacy claims for epoetin alfa (Epogen®) will process as a preferred drug on the Louisiana Medicaid Single PDL, and **do not require prior authorization**. Epoetin alfaepbx (Retacrit®) will remain preferred on the PDL. The PDL document will be posted on April 1, 2022 to reflect this change in PA status.
