

SUBJECT: Louisiana Medicaid Pharmacy Point of Sale Quantity Limits and Maximum Daily Dose- April 2023

Effective April 1, 2023, the Louisiana Medicaid Fee for Service (FFS) Pharmacy Program and Managed Care Organizations (MCOs), in consultation with the Drug Utilization Review (DUR) Board, will implement/modify quantity limits and/or maximum daily dose for select medications. The edits apply to pharmacy claims submitted to FFS and MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare).

Quantity Limit

The agents listed in the chart below have quantity limits at Point of Sale (POS).

Medication	Quantity Limit
Mavacamten (Camzyos™)	30 capsules per 30 days
Rimegepant (Nurtec® ODT)	16 tablets per 30 days
Tadalafil Suspension (Tadliq®)	2 bottles (300ml) per 30 days
Treprostinil Inhalation Powder Titration Kit (Tyvaso DPI™)	1 titration kit per 365 days
Treprostinil Inhalation Maintenance Kit (Tyvaso DPI™)	1 kit per 28 days

Pharmacy claims that exceed the quantity limit will deny at Point of Sale (POS) with:

MCO Only: The pharmacy claim will deny with a **NCPDP rejection code**.

FFS Only: **NCPDP rejection code 76** (Quantity and/or days' supply exceeds program maximum) mapped to
EOB code 457 (Quantity and/or days' supply exceeds maximum.)

Quantity Limit Override

FFS Only: Upon consultation with the prescriber to verify the medical necessity of excessive quantity, the pharmacist may override the denial by submitting the following override at POS:

NCPDP 439-E4 Field (Reason for Service Code) **EX** (Excessive Quantity)

NCPDP 440-E5 Field (Professional Service Code) **MØ** (Prescriber Consulted)

NCPDP 441-E6 Field (Result of Service Code) **1G** (Filled with Prescriber Approval)

Maximum Daily Dose of Amifampridine (Firdapse®)

Amifampridine (Firdapse®) has a maximum daily dose at Point of Sale (POS) shown in the chart below.

Medication	Maximum Daily Dose
Amifampridine (Firdapse®)	80 mg/day

Pharmacy claims for amifampridine (Firdapse®) which exceed the maximum dose of 80 mg per day will deny with:

MCO Only: The pharmacy claim will deny with a **NCPDP rejection code**.

FFS Only: **NCPDP rejection error 88** (DUR Reject Error) mapped to
EOB Code 529 (Exceeds Maximum Daily Dose)

Additional Information:

FFS Only: Most pharmacy claim denials can be overridden in emergency situations at Point of Sale. If it is necessary to override the claim, "03" can be entered in **NCPDP field 418-DI** (Level of Service). Refer to www.lamedicaid.com for the POS User Guide and override procedures.

MCO Only: If assistance is needed to override the quantity limit, contact the health plan. (See contact information at the end of this document.)
