SUBJECT: Louisiana Medicaid Pharmacy Coverage Update for

At-Home Over the Counter (OTC) COVID-19 Diagnostic Tests

At-Home OTC COVID-19 Diagnostic Tests

The Louisiana Medicaid Pharmacy Program is retracting the August 28, 2024 memo, which ended coverage for at-home OTC COVID-19 diagnostic tests. At-home OTC COVID-19 diagnostic tests coverage will continue with a monthly limit through December 31, 2024. Effective October 1, 2024, the Louisiana Medicaid Pharmacy Program will have a maximum benefit of the OTC COVID-19 diagnostic test at 2 tests per beneficiary per month. Pharmacy claims are submitted to Gainwell for FFS and to Magellan for all the MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare).

Due to the end of the Public Health Emergency (PHE) for COVID-19, declared under Section 319 of the Public Health Service Act, the Pharmacy Program will access a copayment for at-home OTC COVID-19 diagnostic tests from October 1, 2024 through December 31, 2024. The copayment does not apply to beneficiaries who are copayment exempt.

Pharmacy claims submitted for at-home OTC COVID-19 diagnostic tests will deny starting January 1, 2025.

MCO and FFS pharmacy claims for the OTC COVID-19 diagnostic test will be subject to pharmacy audits for proper utilization. The OTC COVID-19 diagnostic test should only be dispensed upon request from a Louisiana Medicaid beneficiary or a prescription from the prescriber.

<u>Denial from Gainwell (FFS Only)</u>: **NCPDP rejection code 70** (Product/Service Not Covered) mapped to **EOB Code 299** (**Product Not Covered**).

<u>Denial from Magellan (MCO Only):</u> **NDPDP rejection code 70 (Product/Service Not Covered) mapped to internal code 50076 (Not a covered pharmacy benefit).**
