**SUBJECT:** Louisiana Medicaid Pharmacy Coverage Update for

At-Home Over the Counter (OTC) COVID-19 Diagnostic

Tests- 2<sup>nd</sup> Revision

The Louisiana Medicaid Pharmacy Program is retracting the August 28, 2024 and September 10, 2024 memos, on the reimbursement policy of at-home over the counter (OTC) COVID-19 diagnostic tests. Effective September 30, 2024, the Louisiana Medicaid Pharmacy Program will end coverage for at-home over the counter (OTC) COVID-19 diagnostic tests. Pharmacy claims are submitted to Gainwell for FFS and to Magellan for all the MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Humana Healthy Horizons, Louisiana Healthcare Connections, and UnitedHealthcare).

## **At-Home OTC COVID-19 Diagnostic Tests**

Due to the end of the Public Health Emergency (PHE) for COVID-19, declared under Section 319 of the Public Health Service Act, the Pharmacy Program will end payment for at-home OTC COVID-19 diagnostic tests on September 30, 2024. **The Centers for Medicare and Medicaid Services (CMS) will not cover at-home COVID-19 diagnostic tests as a pharmacy benefit after September 30, 2024.** COVID tests will continue to be covered as a medical benefit. Eligible covered beneficiaries can access their healthcare provider for vaccines, treatments, and diagnostic testing as usual.

Pharmacy claims submitted for at-home OTC COVID-19 diagnostic tests will deny starting October 1, 2024.

<u>Denial from Magellan (MCO Only):</u> **NDPDP rejection code 70** (Product/Service Not Covered) mapped to **internal code 50076** (Not a covered pharmacy benefit).
