SUBJECT: Louisiana Medicaid Pharmacy Single Preferred Drug List (PDL) Update

for Dulaglutide (Trulicity®) Pen Injector- Effective April 1, 2021

Effective April 1, 2021, the Louisiana Medicaid Fee for Service (FFS) Pharmacy Program updated the Preferred Drug List (PDL) status of dulaglutide (Trulicity®) pen injector from non-preferred to preferred. The update of dulaglutide (Trulicity®) pen injector to preferred PDL status applies to pharmacy claims submitted to FFS and MCOs (Aetna, AmeriHealth Caritas, Healthy Blue, Louisiana Healthcare Connections, and UnitedHealthcare).

Dulaglutide (Trulicity®)

Due to a shortage and discontinuation of exenatide ER (Bydureon®) pen injector, the status of dulaglutide (Trulicity®) pen injector is updated from non-preferred to preferred. Louisiana Medicaid FFS Pharmacy Program has determined that this change to preferred status will allow ease of access for patients and dispensing pharmacies. Pharmacy claims for dulaglutide (Trulicity®) pen injector will process as a preferred drug on the Louisiana Medicaid Single PDL, and do not require prior authorization. Dulaglutide (Trulicity®) pen injector will have a preferred status on the PDL, until review by the Pharmaceutical and Therapeutics (P&T) Committee. Some Point of Sale (POS) edits may apply to dulaglutide (Trulicity®) pen injector.
